

# **Professional Qualifications -**International Benchmarks

It is encouraging to note that in 2005 the number and quality of applications were maintained, demonstrating that the benefits of achieving one of The Textile Institute's long-established and highly valued professional qualifications are still recognised and appreciated by both individuals and employers. The range of jobs held by successful applicants was as broad as ever and applications were received from members around the world, with Asia being particularly well represented.

More courses are being submitted for accreditation as University Departments also realize the benefits of benchmarking their programmes to other textile programmes around the world. Courses in Textile Technology at the Universiti Teknologi Mara, Malaysia, and at Kumaraguru College of Technology, India, were accredited for ATI later in 2005 and several other submissions are currently in the pipeline.

It is pleasing to report that, although the Institute's central Convocation ceremony was discontinued some years ago, the presentation of certificates is still undertaken at local events from time to time and Sections such as Lahore organize more formal Convocations to celebrate the achievements of their members.

The honorary awards of Companionship and Hon Fellowship were re-introduced in 2005. In addition to the Companionships presented at the Parliamentary Lunch, mentioned earlier by the President, Honorary Fellowship was awarded to Dr Balasubramanian of India and presented locally. These awards will continue in 2006 and consideration is also being given to the reintroduction of other honorary awards in subsequent years.

# **Business Information** Services

2005 was an active year for BIS with nearly 7000 enquiries dealt with on a variety of textile related subjects worldwide. As in previous years we have worked to streamline the service whilst protecting the integrity of the vital role the department plays in the retention and recruitment of new members. We continue to monitor the Carpet Foundation Quality Mark, and as it has been proposed to expand the scheme into a wider industry base we look forward to our continuing contribution.

In 2006 some interesting projects are in the offing. In addition we are continually looking to create similar projects for our registered consultants who can apply their specialist skills and expertise to organisations worldwide.

The main aim for 2006 is to look at purchasing new information sources to increase the availability of reliable industry data for members.

The Lord Barnby Foundation Trust has continued to support the Lord Barnby Foundation Library and the donation, as always, was gratefully received. We have significantly updated the library journal and book stock and have now included MINTEL reports for various industry sectors.

The Recruitment Register has continued to attract new members and has proved to be as popular with graduates as it is with professionals seeking new employment opportunities. From January 2006 this service will become an integral part of members' benefits packages and will no longer attract an extra registration fee. The service will also be extended to offer links with both employers and other agencies, thus widening the opportunities on offer.

# **Publications**

2005 was a year of major achievement. All the

outstanding back issues of The Journal of The Textile Institute (JTI) and Textile Progress were published and the new issues for 2005 were produced on schedule by Woodhead Publishing Limited in the new professional format in both hard and electronic versions.

This year also saw the retirement of two highly valued editors. Dr Ian Holme handed over the mantle of Editor-in-Chief of the JTI to Dr David Buchanan at the beginning of 2005 and Mr Jack Smirfitt, who had edited Textiles Magazine for more than ten years, relinquished his role to Ms Vanessa Knowles later in the year. # Chairman's Report



This is the third and final year of my chairmanship and I am pleased to say that 2005 was the year when the fruits of our previous reorganisation and modernisation of the Institute have begun to be harvested. As the annual statements show, the Institute, for the second year

running, shows a surplus on its management accounts and the net asset value is now positive again. Since 2003 we have reduced our expenditure to less than our income. In hard cash terms, our expenditure has reduced from a figure of just over £500k to less than £350k. All this has been undertaken without increasing membership fees and as a consequence, the TI is a much leaner organisation with service to members being its primary concern.

These changes have not been easy and I must thank the dedication and hard work of our small staff led by Helen Yeowart and located at the Manchester and London offices. Without them, the streamlining of the Institute and its now much healthier financial condition could not have been achieved.

One major achievement during 2005 was the catching up in our publication backlog of JTI. Thus subscribers received all outstanding volumes up to and including 2004 plus the new 2005 edition, externally produced by Woodhead Publishing under the editorship of David Buchanan. This new issue is also available in an electronic format. In parallel, Textile Progress has also been successfully transferred to Woodhead under the editorship of Professor Xiaoming Tao of Hong Kong Polytechnic University.

Following the decision of Mr Jack Smirfitt to relinquish his editorship, our membership magazine

textiles also has undergone a further modification and is now produced by Pebble International. The Institute is indebted to the immense work that Mr Smirfitt has put in over many years editing the magazine in its various forms and I would like to take this opportunity of thanking him publicly.

The annual World Conference took place during March in Raleigh, North Carolina and was a great success with over 200 delegates attending. The conference was also a platform to announce the election of our new World President, Mr Gerry Mauretti of Engineered Yarns, Massachusetts. In May Mr Mauretti took over his position from Lord Simon Haskel, to whom both the Institute and I are indebted for the work that he has put in furthering the interests and standing of the TI on the one hand and his support of myself during the last three years of challenge and change. Lord Haskel has continued supporting the Institute not least by hosting the annual Parliamentary Lunch, as mentioned above.

Finally, the membership decline of the last few years, which slowed down last year, has been further stabilised and Board and Council are focussing on membership growth during 2006. It is therefore with confidence that I can hand over the Chairmanship of Council during 2006 to Mr Mervyn Davies, formerly of Marks and Spencer plc. He brings a commercial steer to the position as well as having experience in the downstream part of the textile manufacturing supply chain where we seek to attract and recruit new members.

TI News largely depends on the membership and the Institute would like to encourage members from both industry and academia to submit their news from all areas of textiles, clothing and footwear.

The website is being developed to provide a more interactive site. All views and suggestions made for improving the TI website have been collected and an amalgamation of these is being put into place over the next six months. Suggestions have included a more user-friendly site, with easier to read, clear and up-todate information and most importantly a secure website. Security of the site was put into place in 2005.

It is pleasing to report a 25% increase in visits to the website, the most popular pages being in the members-only area, including the International Textile Calendar, Patron, Section, Events and Special Interest Group pages.

The TI London Office is conveniently situated in central London, to represent the southern area of the UK. Bill Bohm is the Manager based at this office and is also the Secretary of both the Design and the Fashion & Technology Special Interest Groups. The London office is also key in supporting the southern Sections of the Institute.



The Parliamentary Lunch, a popular event in the TI annual calendar, was held in the Terrace Room of the House of Lords on Friday 11th November 2005. It was hosted by The Lord Haskel, immediate Past President of the Institute.
