Message from the World President



This is my second Annual Report as World President of The Textile Institute since my inauguration in May 2018 a role I have enjoyed immensely. I have had the opportunity to meet so many members in the UK and those based overseas all of whom have been incredibly welcoming to me.

We are living in unprecedented times. We only need to look at the first quarter of 2020 to understand why focus on building a Textile Institute with a lasting sustainable future is important:

- Outbreak of the Coronavirus
- Natural disasters effecting many worldwide
- Britain's exit from the EU
- Trade tensions between various countries worldwide
- Protests in major cities around the world
- Ongoing extinction rebellion marches
- Political, economic and social unrest
- International travel suspended

Many of you have been involved in helping shape the future of The Textile Institute and as you can see there have been extensive external factors to take into consideration and I thank you for your continued participation.

Despite these external factors the Institute continues to support many awards, bursaries and sponsorships including; Manchester and Cheshire Section Textiles & Life 2 Award, The Textile Institute Young Persons Award, The Golden Shears Awards, and supporters of New Designers, the Royal Opera House Design Challenge, Sri Lanka Section Awards and the Bradford Textile Society Design Competition to name a few. We are also proud partners with Artsthread a global graduate site.

We hosted an Awards Ceremony in Manchester in May 2019 following the Institute's AGM. Guests attended from India, Sri Lanka, Pakistan, Europe, US, Japan, Bangladesh and China. The North India Section of the TI celebrated its 30 year anniversary. We will continue to nurture and nourish textile talent globally.

The Textile Institute continues to attend major trade shows around the world and were supporting partners of ITMA 2019 the International Textile Machinery Association exhibition, held in Barcelona, Spain and Techtextil 2019 in Frankfurt, Germany where the TI staff welcomed friends old and new.

The Textile Institute is proud supporters of the Sustainable Clothing Action Plan, an industry-led action plan which delivers positive environmental and economic outcomes to organisations, by reducing carbon, water and waste through the SCAP 2020 Commitment, using collective action to minimise the environmental impact of our clothes.

We have been developing our publications portfolio in the past few years with a long-term strategic goal to be a leading publisher worldwide representing the whole textile industry. The Textile Institute's portfolio of publications includes books, journals, magazines and monographs of worldwide interest. We have chosen globally recognised publishers to communicate essential information and research in all areas of textiles including science, engineering, economics, management, marketing and design.

In the Spring of 2020 we will launch our brand new website. It will enable us to interact with new members, involve new audiences and promote textiles so that we can have better interaction with members, our sections globally and the wider industry.

I am excited about our Textile Institute's future.

Message from the Chair of Council



Thank you for taking the time to read the Chairman's message as part of The Textile Institute's (TI) Annual Report. As previously, it is my great pleasure to fill you in on some of the important activities that have taken place since the 2019 Annual Report was issued.

The Chairman's role is to ensure that the Members of The TI Council, who are all trustees of this professional, charitable body, act diligently to ensure the TI remains a going concern. I can confirm that Council has worked well over the past year in this respect, despite a difficult financial period globally. As well as discussing budgetary matters it must also conform to the regulations of the Charity Commission, which it consistently refers to. As more TI members wish to get involved with its work, so more have shown an interest in joining Council and in 2019, more members were nominated than there were seats for, necessitating a ballot for places. Long may this interest continue.

In my last message to you I advised that there had been several staff changes at TIHQ, some of which had had an impact on member engagement. Despite several new appointments in 2019, TIHQ has again suffered from a 'churn' of personnel and so new appointments have been necessary. Nevertheless, senior staff are confident that recent appointments are already having a positive effect on the operation as a whole and we look forward to this continuing in 2020.

Both as a result of periods with low staff resource and technical issues with the website/data management, the distribution of reminders for individual member fee payments was impeded during 2019. Members so affected have been contacted through a manual system of distribution and a considerable amount of membership income has been recouped. Staff are to be congratulated for this.

To assist with future fee collection, members agreed to a streamlining of members' anniversary dates at the AGM in May 2019. This system will be rolled out during 2020 and will help to improve cashflow. Despite some decline in Individual Membership income in 2019, staff attendance at ITMA Barcelona and Techtextil were important for networking and the development of new contacts which has resulted in new member acquisitions. Corporate Membership has continued to grow, which is great news.

Our Sections around the world have been very active. It is impossible for me to mention all activities and I hope Sections will forgive me for missing anything they have done! The Sri Lanka Section celebrated its 45th Anniversary and held an awards ceremony as part of its AGM. Its headquarters have recently moved to the University of Moratuwa and I know the Section will want to thank Brandix for being its host for many years previously. In addition, the North India Section (NISTI) celebrated 30 years since its inception with a series of events and the launch of a new website. The Chairman sent a message of congratulations and the World President, a short video message. Both the Chairman and World President,

separately, visited members in Australia, China, Hong Kong SAR, and New Zealand. In the UK, the London & SE England Section continued to hold an interesting schedule of events throughout the year whilst the Manchester & Cheshire Section hosted the 2nd Textiles and Life conference, designed to allow research students to present their work to a supportive and non-judgemental audience.

The Professional Qualifications department has seen significant growth in both accreditation and approved course submissions. An increase in the number of individual applications has also been observed, with Fellowship being the most desired qualification. The committee works hard to advise and support both individuals and colleges/universities with their paperwork. Consequently, an increase in applications from industry members has been seen, which is very welcome.

The Publication's department book portfolio is still having a positive effect on the income stream. textiles magazine is keenly awaited by members and provides valuable information on subjects of current interest together with Section and Institute news. The Journal of the Textile Institute and Textile Progress are key research journals for our industry and are regularly referenced by others.

The department welcomes interest from new authors and reviewers. The Institute would also like to hear from members worldwide willing to offer their expertise to assist its 'ask an expert' service; its short courses; and consultancy queries.

This is my last report to you as Chairman of Council. Having been in the Chair for 5 of the last 7 years it is important for someone else to have the opportunity to take the reins and I wish my successor all the very best in the role. As a membership organisation we all have responsibility for ensuring a successful future for this, the global chartered professional body for our industry, and I hope that the efforts we put in to encourage young professionals to join us pays off. The eagerly anticipated new website will greatly benefit the Institute in this respect and I thank everyone who has been involved in its design and development, ahead of its launch.

I am truly grateful to the Institute staff and my fellow trustees for the efforts they put in across the year to promote the Institute and ensure it runs in a safe, secure and proper manner. The dedication and professionalism of senior staff at TIHQ deserves special mention. The Institute just could not survive without them.

A final reminder that this is **your** Institute. An organisation born 110 years ago and which has held a Royal Charter for almost 100 of those years. It is an organisation with a rich history and heritage and with your help and foresight will have an assured and successful future.

Honorary Treasurer's Report



Once more I must thank the team at The Textile Institute for their efforts over the year. We have again been struggling to retain and recruit staff to administer the TI. This has impacted on our income particularly from Membership fees. I should also state that the rest of the team have worked extremely hard to cover

for the lack of staff.

It is likely to be a 'break even' or a small profit year given the above issues.

Our income depends greatly on the amount received from the Publications area and we all should be aware that this is half our total income. We have seen a decrease in income from this area and this will impact on the overall figures.

Professional Qualifications department has had a very successful year with significant growth in both accreditation and approved courses. For individuals the CText FTI was the most popular professional qualification – this varies year on year.

The Parliamentary Lunch remains a highlight of the year and income from this event remains good and included sponsorship from TI partners Taylor and Francis. In addition, the TI held an Awards Ceremony in 2019 which welcomed generous sponsorship from Verivide Ltd and the Cotton Council Incorporated. The TI is very reliant on these sponsors for the success of such events which allows the international office to run such activities.

The TI did not hold a World Conference in 2019 and so no income will be received from this event.

The Textile Institute is in the planning stage for a new website following the recent issues with the current site which has affected members and membership income. Pentland Brands Ltd has made a generous donation along with a number of Individual Members to allow the TI to begin the website project a year earlier than planned. The Institute is extremely grateful to its supporters which will allow the site to be launched in the first half of 2020.

As well as sponsorship for events the Institute continues to receive a generous donation from the Lord Barnby a past World President of The Textile Institute.

Income from magazine advertising remains constant and the new website will come on stream early in 2020 to further increase our income from advertisements.

As stated earlier the areas for our focus must be Publications and Membership both Corporate and Individual.

Expenditure is more predictable with some savings in staff costs as the TI was under-staffed at periods during the year.

Borrowing arrangements with our Bank remain secure with a manageable overdraft. The overdraft is secured against an Investment Portfolio.

The Institute did not need to borrow any further money from either internal or external funds during the year.

For 2020, I believe we will be financially challenged but with the focus on increasing Individual and Corporate Membership and the continued income from the Publications Department.

We should also see additional income following the launch of the new website.




Professional Qualifications

Individual Qualifications

Since 1926 The Textile Institute has conferred professional qualifications to Individual Members. Members can apply by filling in an application form which is assessed by a committee of peers.

Licentiateship is awarded to those with a good level of knowledge in one specialist area and a general awareness of textiles and related industries. The holder of this qualification can use the post nominal letters LTI.

Associateship is a chartered professional qualification awarded to those with specialism in one area of textiles and a broad general knowledge of textiles and related industries. The holder of this qualification can use the post nominal letters CText ATI.

Fellowship is the highest level professional qualification awarded by The Textile Institute. Conferred to those who fulfil the requirements of CText ATI but have also made a major personal creative contribution. The holder of this qualification can use the post nominal letters CText FTI.

Accreditation

The TI accredits a wide range of courses worldwide to both Licentiate and Associateship level. Students graduating from these courses are able to apply after a shorter period of postgraduate work experience.

The courses are peer assessed and qualifying courses are able to demonstrate programme quality and excellence of provision.

Along with the individual qualifications the accreditation has also been revised to explicitly open up the range of courses being taught in textile related disciplines worldwide. New application forms have been created to make the application process more streamlined and user friendly.


