MEMBERSHIP TYPES

Standard Membership

Individual Membership at the standard subscription rate.

Association Membership

Members of the AATCC, ASBCI, CTES, EDANA, HKRITA and ITTA can benefit from this rate.

To apply for this rate you will be requested to provide proof of membership status of your association.

Retired

To apply for this rate you will be requested to provide confirmation of retirement status. There is no age restriction for this rate.

Graduate

To apply for this rate you will be requested to provide proof of graduate status eg graduation certificate. Graduates can claim this rate if you have graduated within the past 36 months.

Unwaged

To apply for this rate you will be requested to provide proof of unemployment status.

ERD 1

To apply for this rate you will be requested to provide proof of earnings. Salary equivalent below GB £3500.00 per year.

ERD 2

To apply for this rate you will be requested to provide proof of earnings. Salary equivalent below GB £3500.00 per year.

Student Membership

To apply for this rate you will be requested to provide proof of student status eg Student ID card or graduation certificate. Students must be enrolled on a full or part time course. You can claim this rate if you have graduated within the past 12 months. This rate does not apply to PhD students.

Corporate Student Membership

To apply for this rate you must be registered on a Corporate Member university undergraduate or postgraduate course. You will be requested to provide proof of student status eg Student ID card or graduation certificate. This rate does not apply to PhD students.
