The 92nd Textile Institute World Conference, which will be held on 3-6 July 2023 will give new opportunities to meet 'in person' textile experts, scientists and industrialists from the across the globe. The University of Huddersfield is the host of the conference and registration is still open to join the event, to have time to be together and share knowledge, exchange ideas, make new friendships and partnerships for cooperation.

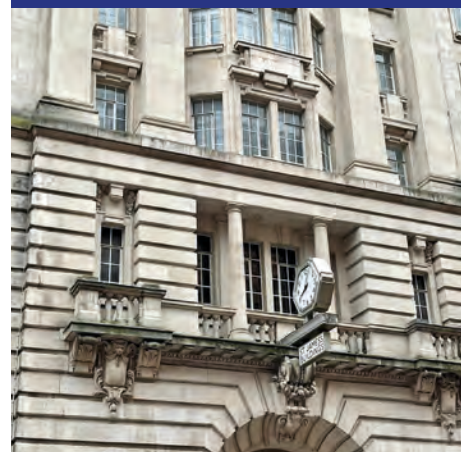

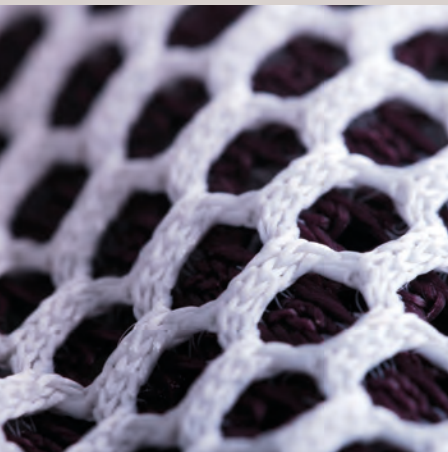

# Chairman of Council

What a pleasure it was to be at the House of Lords for The Textile Institute Parliamentary Lunch on 4 November 2022. This was the first in-person TI event I had been able to attend since the pandemic and was the first opportunity I had had as Chairman to see fellow TI members in person.

It was not surprisingly a great event and so many stayed behind after the Lunch to take the opportunity to talk to friends and colleagues they had not seen in almost three years. Professor Julian Ellis OBE CText FTI gave a fascinating speech on his career including his experience in being an expert witness in court and paid tribute to how his TI membership and qualifications had helped him. Our President, Associate Professor Malgorzata Zimniewska CText FTI then reported on all the TI had managed to do despite all the restrictions we had had to cope with worldwide.

There can be no doubt that being able to hold meetings and seminars virtually has allowed the Institute to remain in contact with its members and continue with many of its activities. I am sure that virtual events will be a vital part of what we do in the future, but I am also of the view that physical, in-person events will still have a very important part to play, not least in our Short Courses. The challenge will be to get the balance right.

This year is an important one for the Institute in more ways than one. The TI World Conference in early July in Huddersfield, West Yorkshire will be the first one since 2018. The programme, on the theme of Sustainability, promises to be an interesting one and again I am sure all delegates will be thrilled to see each other in person. The Journal of the Textile Institute will also be celebrating a centenary of published research in 2023, which will culminate in a special edition of the Journal. All our journals are doing well and we value the partnership we have with Taylor & Francis.

We also value the relationships we enjoy with Elsevier with whom we publish The Textile Institute Book Series and with CRC with whom we publish The Textile Institute Professional Publications. Do not forget that as a member of the TI, you receive a 20% discount on purchases and if you want to submit book proposals Rebecca Price at TIHQ is there to help. Finally, we value the continued support of the Lord Barnby Foundation which helps support the upkeep of the TI library.

Your TI Qualifications are invaluable, particularly when times are uncertain as they are now in so many parts of the world but remember that you have to retain your membership to be able to use them, so do ensure that you are up to date with your subscription.

Finally, in my last message to you as Chairman of the TI Council, I should like to thank everyone who has helped support the TI over the last three years. These have been unprecedented times and the contribution of so many has been unprecedented. This has helped me enormously (I am yet to chair an in-person or even a hybrid Council meeting). I have also been supported, as have all TI members, by the TIHQ staff led by Stephanie Dick who have risen to the challenge of adapting their work patterns as they have sought to maintain the same level of service to all.



# Honorary Treasurer's Report

This is my third Honorary Treasurer's report and again it has been impacted by the ongoing Covid-19 pandemic. First, I must thank the team at The Textile Institute for their efforts over what has been another challenging year. The pandemic has resulted in a change to working practices throughout the year, but this year a revised office attendance has been achieved with the office being manned with at least 2 staff every day.

The recovery from the pandemic has had a significant impact on the Institute's income but this financial year has seen an improvement in overall income.

Publications was again one of the main income streams for the Institute with an increase in royalty payments. The increase in royalty is due to higher number of downloads and Textile Progress catching up with its publishing schedule as well as a slightly more favourable exchange rate working in our favour. Publications however is still the largest income stream.

During the year Corporate Membership was a little above budget, with a big push on membership recovery Individual Membership was also above target for the year.

The Professional Qualifications Department was well under budget in terms of new and ongoing accreditations. Applications for professional qualifications was also well under budget.

The Events Department portfolio suffered significantly due to the pandemic, but I am pleased to say that with no restrictions the events department has significantly increased its income. The Parliamentary Lunch has always been a highlight of the TI events calendar and for the first time in three years the lunch was able to go ahead and was extremely successful

Another welcome source of income for the Events Department is the short course portfolio. Two Introduction to Textiles short courses were able to be delivered this year. Both courses were held as face-to-face programmes and were fully booked.

In addition to the standard short course portfolio an extremely successful bespoke short course was developed and has been delivered two times during the year with further courses expected to be delivered during the coming year.

Further income came from the TIWC 2023 pump priming payment. So, the events department has had a very successful year and its income was well above budget. Succession planning is already in motion for subsequent TIWC.

On a brighter note, the Institute has benefitted from an extremely generous legacy during this financial year.

Overall expenditure has been reduced to a similar level as last year. Borrowing arrangements with our bank remain secure with a manageable overdraft which was used to maintain cash flow over a crucial few months. The overdraft is secured against the Institute's investment portfolio. The Institute did not need to borrow any further money from either external or internal sources during the year.

For 2023 I believe that the Institute will still be financially challenged but with the new website now in operation and a focus on increasing both Individual and Corporate Membership, the Publications Department maintaining its income and the ability of the Events Department to hold events income should remain stable and enable the budget to stay on track.

# Professional Qualifications

## Individual Qualifications

Since 1926 The Textile Institute has conferred professional qualifications to Individual Members. Members can apply by filling in an application form which is assessed by a committee of peers.

Licentiatehip is awarded to those with a good level of knowledge in one specialist area and a general awareness of textiles and related industries. The holder of this qualification can use the post nominal letters LTI.

Associateship is a chartered professional qualification awarded to those with specialism in one area of textiles and a broad general knowledge of textiles and related industries. The holder of this qualification can use the post nominal letters CText ATI.

Fellowship is the highest level professional qualification awarded by The Textile Institute. Conferred to those who fulfil the requirements of CText ATI but have also made a major personal creative contribution. The holder of this qualification can use the post nominal letters CText FTI..

## Accreditation

The TI accredits a wide range of courses worldwide to both Licentiatehip and Associateship level. Students graduating from these courses are able to apply after a shorter period of postgraduate work experience.

The courses are peer assessed and qualifying courses are able to demonstrate programme quality and excellence of provision.
